^{*} Cut off time - this is the cut-off time by which the payment order must be received by the bank so that it can be executed in accordance with the mode of execution selected by the customer.

** SHA mode - an option where the fees related to the execution of the transfer are divided between the ordering party and the transfer beneficiary. In practice, this means that the payer pays the costs of his bank (e.g. for the transaction mode, execution), and the remaining costs are deducted in the amount that the recipient ultimately receives. The Amronet.pl service has met the expectations of its customers and offers the cheapest foreign transfers.

For banks integrated with the Amronet.pl website: Alior Bank (former BPH SA, T-Mobile banking services), PEKAO SA, Santander Bank Polska (former BZWBK), PKO BP (former Nordea Bank, Inteligo), Raiffeisen Polbank, BNP BGŻ Paribas and Millenium Bank, the customer does not incur any additional costs for withdrawing funds.

*** Express transfer - instant transfers in which the funds are booked on time D, i.e. on the day of the order, taking into account the cut-off time by which the instruction should be received for the payment to be made under the conditions contained in point X.

If the user conducts unauthorized transactions, the operator has the right to return the funds at the user's expense, charging his account with a handling fee.
